Florida Building Commission adopts 2008 NEC, exempting GFCI requirement on residential pools

On Tuesday, June 9, the Florida Building Commission (FBC) held a final rule hearing on glitch rule 9B-3.047, which encompassed a number of proposed changes to the 2007 Florida Building Code (the code). Changes within this rule ranged from items that affect interior designers to the 2008 National Electrical Code and from roofing to energy related code language. This made for a very interesting rule hearing with a variety of testimony and discussion. Most important to the pool industry was the 2008 NEC discussion.

In April, the FBC voted to adopt the 2008 NEC but exempt the GFCI requirement on residential pools. However, in the interim, the National Electrical Manufacturers Association (NEMA) and others received word of this action and were in attendance at the June 9 meeting to register their objections. The FBC heard testimony from a NEMA representative and an electrical contractor asking the FBC to reverse their original decision and to adopt the 2008 NEC in total. Representatives from FSPA and other groups provided testimony to rebut the NEMA claims and encourage the FBC to stand by their original decision.

Larry Brown, FSPA Central Florida member and electrical contractor for Mid Florida Pools, did a superb job rebutting the NEMA testimony. His comments were well received by both the FBC and those in the audience. He was a key part of this successful effort. In addition, comments were made to

the FBC by UPSA members. FSPA President Alan Cooper and member Tony Caruso were in attendance to provide additional testimony as warranted. To sum up the discussion, Commissioner Ken Gregory spoke to his fellow Commissioners asking them to vote down a motion that would have adopted the 2008 NEC in its entirety, effectively reversing the original decision. The FBC agreed with Commissioner Gregory and the testimony the pool industry provided, ultimately voting down the motion 16-6. The original decision to adopt the 2008 NEC except for the GFCI requirement on residential pools

The action by the FBC eliminates a device that would have increased

costs to consumers, and while doing so would not have provided any additional benefit. Rather, requiring a GFCI would have caused nuisance trips on the pool pump, increasing safety and health issues as pools would not be circulating. It is clear the FBC action ensures that Florida citizens and tourists are better protected and an additional, unwarranted cost has been eliminated. After this victory, FSPA President Alan Cooper stated, "This epitomizes what our government relations program is all about. Further, it is an excellent example of the importance of having a swimming pool contractor on the FBC."

Governor signs legislation significant to the industry

Since the conclusion of the 2009 Legislative Session, Governor Crist has signed bills that significantly impact the swimming pool industry. What follows is information on FSPA supported legislative initiatives that were signed into law last month.

Department of Business & Professional Regulation: Governor Crist signed into law HB 425, by Rep. Plakon (R-Longwood), the business

regulation streamlining legislation that eliminates unnecessary regulatory burdens for licensed individuals and applicants.

This legislation includes an FSPA top legislative priority--the homeowner warning bill crafted by FSPA to better inform the homeowner of their responsibilities and reduce unlicensed contractor activity. This language strengthens

the existing disclosure statement for any property owner who applies for a residential owner-builder building permit. Applicants are required to read and sign off on a multi-page form warning homeowners of the serious legal and financial liabilities they face when acting as their own homeimprovement contractor. Building departments, aware of the pending changes, have already begun to revise their owner/builder disclosure statements, many plan on having the homeowner initial each statement. HB 425 goes into effect October 1, 2009 and includes numerous provisions to make licensure more efficient. Notable provisions for the

swimming pool industry include the following:

- Removes the notarized application requirement in order to facilities online form submission.
- Increases fee caps for construction contractor licenses to \$250.
- Removes the requirement that applicants for registered construction and electrical contractor licenses must provide a copy of a local occupational license.
- Corrects any remaining references to the occupational license with the business tax terminology.
- Removes the requirement that

We cannot just rely on the members of the committees; they must have your individual and industry input. Read Jennifer's article for the complete report of the FBC meeting.


One of the reasons we have been

Salt systems done right

Reprinted from the September, 2008 issue of Florida Pool Prosm By Rick Howard, Rick's Pool Service, Inc.

As a warranty provider for several manufacturers of chlorine generators we notice a few mistakes being made over and over. The biggest mistake we find is improper sizing of the systems.

Manufacturers make several unit sizes capable of handling certain gallons of water. Understand that these units are sold worldwide and our beloved Florida is one of the most demanding environments for salt systems.

We advise never installing a system that is marginal for the gallonage. Whereas nine months out of the year you won't have issues, the other three will result in long pump run times, shortened cell life and most likely, unhappy customers.

In our market, to stay out of trouble, consider the gallonage rating to be 75 percent correct. Example: a unit rated for 20,000 gallons should be perfect for 15,000 gallons. That way you are assuming some extra output for our most demanding months of June, July and August. The end result will be a longer cell life, better water quality and happy customers.

Training and education are key to a positive outcome. Most manufacturers provide training opportunities specific to proper sizing and installation of their units (one has classes every month!)

and generic classes are available at our (FSPA) Show every year!

Field techs should attend classes too. They must have a good understanding of all the operational requirements. Most importantly, they need to understand the chemistry parameters required for proper operation. Different systems require slightly different salt levels!

One manufacturer used to print on their power supply "over production shortens cell life." We often see chlorine levels way above 10 ppm. This does result in shortened cell life and other issues... staining, etc! Learn how to adjust the output so you don't over chlorinate the water. Remember we're making fresh chlorine daily!

If you are selling a system to a homeowner the time you spend explaining how it works will be invaluable. These are not install it and forget it systems. Proper sizing and water testing is very critical to proper performance and longevity. Also consider the cell placement. They must be accessible for servicing and replacement.

Educating yourself, staff and customers is key to satisfied performance, longevity, ease of use, great looking pools and happy customers!





an applicant obtain a certificate of authority (QB license) for a business organization when the applicant proposes to engage in construction contracting under a business organization structure. However, it requires an applicant for a contractor's license to apply to the DBPR to act as the qualifying agent of the business organization as part of the licensure requirement for registration or certification as a contractor.

Read Rep. Plakon's press release on HB 425 at www.floridapoolpro. com. FSPA will be sure to send out any further information from DBPR on this significant piece of legislation.

Workers' Compensation: Governor Crist signed into law HB 903, by Rep. Flores (R-Miami), the workers' compensation legislation that FSPA worked on with others in the construction industry in order to keep your rates from increasing. This legislation addresses the limitation on attorney fees to correct a Supreme Court ruling in Murray vs. Mariner that overturned the 2003 workers' compensation reform measures relative to "reasonable" attorney fees due to ambiguity with the term "reasonable." As a result of the governor's approval, regulators announced that a reduction in the workers' compensation rate is expected to save Florida employers \$172 million on their premiums after


the bill goes into effect on July 1.


Growth Management: Governor Crist signed into law SB 360, by Sen. Bennett (R-Bradenton), the growth management bill that includes a provision to extend construction, building permits, development orders and environmental permits for a period of two years. The affordable housing bill was also amended onto SB 360, authorizing counties to use tax revenues to provide workforce, affordable and employee housing.

Impact Fees: Governor Crist signed into law HB 227, by Rep. Aubuchon (R-Cape Coral), the impact fee legislation that levels the playing field for the burden of proof standard when impact fees are challenged.

Property Insurance: Governor Crist signed into law HB 1495, by Rep. Nelson (R-Orlando), relating to property insurance. This bill makes reforms to property insurance provisions and specifically requires a 10% rate increase for Citizen's property insurance holders to move the company to more of an actuariallysound entity.

Watch the e-newsletter and the August Florida Pool Pro (sm) for final action on the remaining legislation awaiting the governor's signature. This includes SB 2064. the construction defects bill and HB 707, the beach water contamination/ public swimming and bathing facilities legislation.

Insurance Update

Controlling property insurance costs

Everybody is looking to conserve resources these days—businesses are hunkering down to make it through these challenging economic times. One of the ways organizations are looking to cut costs is by reviewing their insurance program. In this article, we will discuss the ways to evaluate your Commercial Property and Inland Marine insurance policies to ensure a cost-effective program.

While reducing property values may appear to be a cost saving factor, it is important to verify that your property and inland marine exposures are valued according to your insurance contract requirements. First, you will want to review your policy to determine its coinsurance basis.

Coinsurance clauses, which apply to partial claims, indicate what percentage of the value of your property must be insured in order to be fully reimbursed for a partial loss. In other words, if it costs \$100,000 to replace the building, and you have 80% coinsurance clause, you must carry \$80,000 for the carrier to pay partial claims in full (less deductibles).

Likewise, if your coinsurance clause is 100%, then the property must be insured for the full amount. If it costs \$100,000 to replace the building, and you have 100% coinsurance clause, you must insure the building for \$100,000 in order to be reimbursed in full (less deductible) for partial claims.

The danger in failing to meet

coinsurance requirements is that your loss is adjusted by the same percentage of the shortfall. In other words, if your building is insured for 50% of the appropriate coinsurance value, your claim settles for 50% less.

Another factor you'll want to consider is whether the policy is based on replacement cost or actual cash value.

Replacement cost reflects the current value to replace the property. If your Commercial Property insurance policy is based on replacement value, the contract requires you to insure the amount of what it would cost to rebuild the structure or replace the contents in today's marketplace, subject to the coinsurance clause.

On the other hand, actual cash value includes depreciation in determining the amount of insurance. Some property policies and many Inland Marine policies, such as scheduled Contractors' Equipment floaters, are based on actual cash value. In those cases, it is important to assess the original cost new and apply depreciation in accordance with the age of the property to determine the proper value to insure.

In today's economic climate, property values are declining, so it is important to determine accurate, yet updated amounts. Making sure your property is insured correctly helps you to pay the proper premiums for your exposures. Better yet, it protects your organization from financial chaos in the event of a loss.

Additional FBC news

The FBC also voted to incorporate into the glitch rule the 64E-9, F.A.C., public pool code revisions. Those portions that deal with the construction of a pool will be made consistent within section 424.1 of the building code. This provides for less confusion among pool contractors, health and building officials. FSPA applauds the FBC and their quick reaction to the recent public pool rule changes in order to incorporate it into their glitch cycle.

Note that the entire glitch rule, including the 2008 NEC and 64E-9, F.A.C. incorporated revisions can be enforced NOW by any jurisdiction (building department). It has been officially adopted by the FBC; therefore, it is enforceable. However, check with your local building departments as some may choose to wait until the rule change has been published and final in the Florida Administrative Weekly. This could result in some jurisdictions not enforcing the new changes until August.

The two new FBC Swimming Pool Subcommittees also met for the first time at the June FBC meeting. The Swimming Pool

Subcommittee to the Plumbing TAC met for organizational purposes and to discuss the task of looking at existing swimming pools in Florida. A motion to have further discussions to develop what would be the trigger to retro-fit existing residential swimming pools with safety devices (barrier and entrapment) passed. At their August meeting they will begin to determine how this would work. In addition, the Pool Efficiency Subcommittee to the Florida Energy Code Workgroup met for the first time. They opened discussion to identify items that this group will need to address regarding options for pool energy efficiency. It was also noted that two new members would be invited to the next meeting. Prior to the next meeting all ideas will be put together in a worksheet. At the August meeting, a plan will be developed for which portion of these issues could be addressed for the 2010 code.



Cox Pools built a pool for the local Boys & Girls Club, participates in the Kiwanis Club program "Every Child A Swimmer" and donates equipment and labor to the local zoo for the animal exhibits that have water features

In April, Cox Pools participated in Kidsfest, an annual Bay County event with about 6,000 parents and kids attending. They signed up hundreds of kids to participate in Red Cross swim lessons and passed out literature about water safety and swimming pool alarms.
